All information is confidential and used exclusively for enrollment purposes and job placement/federal loan repayment efforts (if applicable).

**A prospective student must:**

- Participate in a campus visit.
- Complete and submit, preferably no later than 60 days prior to class start, the Stewart School Enrollment Application with the required \$50.00 application fee.\*
- Submit a copy of high school diploma or official final high school transcript with graduation date, or GED Certificate with date of completion. \*\*
- Submit a copy of a valid State Issued Photo ID.
- After receiving acceptance notification, submit \$100.00 deposit fee no later than 30 days prior to class start\*.

\*Application/registration fees submitted after the deadline may be considered if class size allows and all other requirements are met. Applicants who have not visited the school prior to enrollment will have the opportunity to withdraw without penalty within three business days following either the regularly scheduled orientation procedures or following a tour of the school facilities and inspection of equipment where training and services are provided. All monies paid by applicant will be refunded within thirty days if requested in writing within three days. Applicants who visited the school more than three days prior will forfeit paid application and registration fees.

Applicants are allowed a short trial period of enrollment (8 scheduled days for Cosmetology, 3 for Esthetic & Massage Therapy and 2 for Nail Technology) where they may withdraw with no tuition due (school retains the application and registration fee along with cost of any kit items used during the trial period). Trial period does not apply to transfer students. For more information, please see the Minimum Cancellation and Settlement Policy in our student catalog, which is on our website or available upon request.

\*\* Home School Diplomas/Transcript are not accepted unless they are from an accredited home school program or an approved program by the State in which the applicant lives, with supporting documentation that the school can easily verify by web search or phone call to said agency. Home School applicants may also provide an ACT test score with a minimum score of 18 or SAT test score with a minimum of 1200 if they are unable to prove accreditation or State approval but have completed a legitimate Home School program.

After the above is completed, Stewart School will send a formal notice of acceptance or rejection. Any applicant who is not accepted by the school is entitled to a refund of all money received by Stewart School.
